ARTICLE 1

The Mount Anthony Union School District No.14 Board of School Directors proposes to incur bonded indebtedness to finance certain capital improvements to the Spinelli Complex at Mount Anthony Union High School, together with related costs and expenses (the "Project") in an amount not to exceed Three Million and 00/100 Dollars (\$3,000,000.00). None (0%) of the Project costs are expected to be eligible for state school construction aid and therefore all (100%) of the Project costs, i.e., \$3,000,000.00, will be the responsibility of the Mount Anthony Union High School District.

Shall bonds of the Mount Anthony Union High School District No.14 in a principal amount not to exceed Three Million and 00/100 Dollars (\$3,000,000.00), subject to reduction from available State or federal funds, if any, be issued to finance construction of capital improvements to the Spinelli Complex?

State funds may not be available at the time this project is otherwise eligible to receive State school construction aid. The District is responsible for all costs incurred in connection with any borrowing in anticipation of State school construction aid.

The lawful voters of the Mount Anthony Union High School District No. 14 (consisting of North Bennington Graded School District, Inc. (NBGSD), and Southwest Vermont Union Elementary School District (SVUESD)) are hereby notified and warned to meet at their respective polling places on September 10, 2024, to vote by Australian ballot on the following Article:

Article 1: Shall bonds of the Mount Anthony Union High School District No.14 in a principal amount not to exceed Three Million and 00/100 Dollars (\$3,000,000.00), subject to reduction from available State or federal funds, if any, be issued to finance construction of capital improvements to the Spinelli Complex?

State funds may not be available at the time this project is otherwise eligible to receive State school construction aid. The District is responsible for all costs incurred in connection with any borrowing in anticipation of State school construction aid.

Legal voters of the SVUESD residing in the Town of Woodford vote at the Woodford Town Building - Route 9, Woodford, Vermont. Polls will be open from 7:00AM to 7:00PM.
