

## Consent of Candidate Local Elections

17 V.S.A. § 2681(a)

This consent is filed with the municipal clerk of the district (town, city, or school district clerk) and should be filed along with a petition. For questions regarding this form, contact the clerk.

The filing deadline for petitions of nomination and this Consent of Candidate form is the sixth Monday preceding the day of the election, no later than 5 p.m.

This consent form is used by election officials to determine the form of and spelling of a candidate's name and use of initials or nicknames for the ballot. Please complete this form carefully, using the exact form of your name as you want to appear on the ballot. You may include a nickname, but you may not include a professional title. (For example: Dr., Esq., or C.P.A.)
